



TERMS AND CONDITIONS OF ENTRY

ELIGIBILITY

1. As the Mid West Art Prize 2023 (MWAP) is a promotion of Western Australian practising artists, entrants must be residents of Western Australia.
2. Entrants can submit a maximum of two artworks.
3. Artworks must be completed between 1 February 2022 and 8 September 2023.
4. All artworks submitted cannot have been exhibited prior to being entered into the MWAP.
5. Artworks of any medium will be accepted for entry, except those made from hazardous materials. If you are unsure about the eligibility of your artwork please consult the GRAG team artgallery@cgg.wa.gov.au
6. As the MWAP 2023 is an acquisitive award, all artworks MUST be available for sale (a 15% commission + GST applies).
7. Artworks must be able to fit through the Gallery's loading doors (2m high x 1.5m wide).
8. An entry fee of \$45 will apply per artwork submitted.
9. Entry fees are non-refundable.
10. Entry forms and fees must be received by the Geraldton Regional Art Gallery by 4pm on Friday 8 September 2023.
11. Late entries will not be accepted.
12. Employees of the City of Greater Geraldton and their immediate families are not eligible to enter.
13. The entrant accepts the Geraldton Regional Art Gallery reserves the right to edit the supplied artist statement to ensure editorial consistency with MWAP 2023 promotional material.

SHORTLISTING

1. Applicants are advised that the MWAP 2023 is a curated exhibition - not all entries will be selected to exhibit.
2. All artworks entered will be subject to a panel of industry professionals who reserve the right to judge and select entries for the MWAP exhibition dependant on the artwork's overall quality, originality, technique, eligibility, and the available gallery space.
3. Feedback from this process is unavailable due to the large volume of entries.
4. Successful applicants will be advised by email by Friday 20 October 2023.
5. Unselected applicants will be advised by email by Friday 20 October 2023.
6. Names of selected applicants will be published on the Geraldton Regional Art Gallery website on Friday 20 October 2023.

COPYRIGHT OF SHORTLISTED ARTWORKS

The Gallery reserves the right to make reasonable reproductions of shortlisted artworks for the limited purposes of publicity, social media and archival reference.



SALE AND EXHIBITION OF SHORTLISTED ARTWORKS

1. Sale prices of entered works must include GST and the City of Greater Geraldton's 15% Sales Commission.
2. Sets or multiples entered as one work will not be sold as separate pieces.
3. If the entrant does not currently hold an ABN, they will be required to fill out a Statement by a Supplier form upon selection.
4. Upon the sale of an artwork, the artist will receive payment for works sold within 30 days of CGG receiving payment from the Purchaser.
5. As the MWAP 2023 is an Acquisitive Award, the overall winning artwork shall become the property of the CGG Art Collection. The same conditions do not apply to prize-winning works in other categories; these artworks will not become the property of the sponsor of the prize but will be available for purchase. If the artwork is wholly digital in nature the City does not require full ownership, just perpetual approval to display the artwork in its venues.
6. Shortlisted artworks may not be displayed to the entrant's exact specifications. However, these will be installed at the discretion of the Curator.
7. All shortlisted artworks must be ready for display, backed with tabs or 'D' rings. The Gallery has a range of standardised plinths for free-standing sculptures.
8. Special display requirements must be discussed with the Gallery Coordinator prior to delivery for installation and must be supplied by the artist.
9. The Geraldton Regional Gallery will provide insurance on all works selected for exhibition whilst on display.

DELIVERY OF SHORTLISTED ARTWORKS

1. No artwork is to be delivered to the gallery until individual artists are invited to do so by notification of shortlisting.
2. All shortlisted artworks must be delivered to either the Geraldton Regional Art Gallery on Friday 17 November or Saturday 18 November 2023 or the Perth Metropolitan Pick Up Point on Tuesday 14 November 2023 between 2pm-4pm. (Address and further details will be provided to shortlisted entrants).
3. All shortlisted entries must be packed to withstand travel. No responsibility will be taken for works damaged while in transit to or from the Gallery. At the conclusion of the exhibition, the Gallery will pack all works for collection in the provided original packing.
4. Artists are to arrange and meet all the costs of freight (delivery and return) of the artworks to and from the Perth pick up point or the Geraldton Regional Art Gallery.
5. All unsold artworks from the MWAP 2023 exhibition must be collected from Geraldton Regional Art Gallery on Friday 9 or Saturday 10 February 2024 or the Perth Metropolitan Pick Up Point on Friday 9 February 2024 between 2pm-4pm. (Address and further details to be advised to shortlisted entrants). Please note that ID will be required on Pick Up. If these dates are not suitable, it is the artist's responsibility to make alternative arrangement with the GRAG. Otherwise, the City cannot be held responsible for the future storage of the art.
